1 Introduction

[Infrastructure Disclosure Platforms](#) (IDP) is a CoST- The [Infrastructure Transparency Initiative](#)- effort to bring in open-source software that meets the needs of governments, the private sector, and civil society to improve transparency and accountability in public infrastructure.

CoST International Secretariat has established a GitHub repository to share and simplify the reuse of digital solutions created by CoST members. IDP grants access to a set of tools that work complementary including disclosure platforms and analytical dashboards.

In this context, this Guide is intended for CoST members, partners, and IT developer teams to facilitate the documentation of digital solutions that have proven to work in specific contexts and have the potential to be replicated.

By creating the IDP, CoST seeks ultimately to promote knowledge sharing and learning across its membership and beyond to help deliver quality infrastructure, strengthen economies, and improve lives.

2 Documentation in GitHub

A guide for CoST Members, Partners and other potential contributors

The documentation is a section of the CoST GitHub Repository that presents the uploaded tool. This section should explain what the tool is, how it is used, and how it can be reused or adapted. The main file is in README.md format, where all documentation must be listed and developed.

2.1 What is the documentation used for?

The documentation explains to new developers what the tool is, how to use it, and how to install it. It is generally the first technical document another developer will turn to when reusing the digital tool. It is recommended to clearly and concisely document digital tools created by CoST Members to increase their reuse. The documentation should answer the following questions:

- What does the digital tool do?
- How does it work?
- How can the digital tool be reinstalled?
- Under what terms can this tool be used?

A common practice is to create a text file named README.txt in the root directory. This file is the main document that either provides documentation or links users to other documentation resources.

2.2 Who is the documentation aimed at?

The documentation's main audience is developers. However, the user guide section is aimed at the tool's end users. If this section is very complex, it is good practice to dedicate

a specific document to it, although the README file should specify the existence of this extra documentation.

2.3 Where is it saved, and what format should be used?

It is saved in a file named README.md. It should be visible in the digital tool's main folder and in Markdown format. If there is extensive documentation aimed at less tech-confident users, it is recommended to save it in a separate document, though it is always good practice to mention and refer to it in the README.md file.

2.4 What information should be included in the README file?

The README file should contain the information needed to install and use the tool. There is no predefined format, but to have a complete README file, CoST Members should at least include the most common sections listed below¹.

- **Description and context:** Description of its features, the context in which it was developed, and the development problems it helped solve.
- **User guide:** Step-by-step guide aimed at showing the end user how to start using the digital tool. This information can go in a separate document if it is too long, but it is good practice to mention it in the documentation.
- **Installation guide:** Installation instructions for reusing and configuring the digital tool. This section is aimed at developers. In another subsection, documentation on other digital tools (libraries, frameworks, database access, and licenses for each resource) should be provided, if necessary.
- **Creators:** Section crediting those who collaborated on creating the tool.
- **License:** Permissions granted to third parties to reuse the digital tool. CoST Members or other partners should specify the type of license and refer to the license.txt or licencia.txt file with the license content.
- **How to contribute:** A section that explains the process for contributing to projects to new developers.
- **Code of conduct:** The code of conduct establishes the social norms, rules, and responsibilities that individuals and organisations must follow when interacting with the IDP or its community in any way. The GitHub platform rewards and helps repositories that have this file. This can be started from a template they suggest when creating CODE_OF_CONDUCT.md. based on the content suggested by the Contributor Covenant.
- **Badges:** Badges are small images embedded in README.md which clearly and concisely specify the tool's status. There are badges for development status, number of downloads, version, social media, etc.

- **Version:** Indicates a list of the versions of the digital tool, as well as the features added to each version.
- **Acknowledgements:** Acknowledgements of other people or organisations who have contributed to the project in some way.

3 Template for CoST Digital Tools

3.1 Description and Context

3.2 User Guide

[Explain the basic steps of how to use the digital tool. This is a great place to share screen captures or GIFs, which could help others understand how to handle the tool.]

3.3 Installation Guide

[Provide a step-by-step guide for how to install the digital tool. In this section, it is recommended to explain the file structure and all the modules included in the system.

Depending on the type of digital tool CoST members and partners use, the level of complexity of installation may vary. It might be necessary to install additional components on which the tool depends. If this is the case, be sure to add the next section.

Dependencies

Describe any external resources which create a dependency for the reuse of the digital tool, such as libraries, frameworks, access to databases, and the corresponding licenses required to access each of these. Listing the latest versions of these external resources that have been tested for use with the digital tool is considered best practice.

3.4 How to Contribute

Infrastructure Disclosure Platforms (IDP) is CoST- the [Infrastructure Transparency Initiative](#)- an effort to support CoST Members and other partners to contribute, explore and reuse open-source digital tools, which can be used in the design and implementation of the CoST disclosure journey, aiming to improve transparency and accountability in the infrastructure sector around the world.

CoST believes that open-source codes developed by our members or partners should be publicly available to help us to contribute to delivering quality infrastructure, strengthening economies, and improving lives.

Therefore, CoST encourages those who contribute to improving these digital tools to share them with the IPD manager. When reusing this digital tool, consider that:

- Have added some new functionality with which you add value for more people to reuse,
- Have made the tool more versatile to support new updates,
- Have fixed some existing bugs,
- Or have simply improved the user interface or documentation of it.

CoST encourages you to return the progress made to the repository. Follow these steps to contribute to the digital tool:

1. Fork the repository.
2. Develop the new functionality or make the changes you create that add value to the tool.
3. Make a "pull request" documenting in detail the proposed changes in the repository.
4. In such a case, your name will be registered in the list of attributions.

If you have not contributed to the repository, but the tool has been helpful to you, we at CoST would love to hear about your experience. Tell us about your experience in an Issue or via email to opencode@infrastructuretransparency.org

In the "pull request," include your username and organisation so we can add them to the list of contributions in the Readme.md.

3.5 Code of Conduct

Our Pledge

In the interest of fostering an open and welcoming environment, we as contributors and maintainers pledge to make participation in our portal and our community a harassment-free experience for everyone, regardless of age, body size, disability, ethnicity, gender identity and expression, level of experience, nationality, personal appearance, race, religion, or sexual identity and orientation.

Our Standards

Examples of behaviour that contribute to creating a positive environment include:

- Using welcoming and inclusive language
- Being respectful of differing viewpoints and experiences
- Gracefully accepting constructive criticism
- Focusing on what is best for the community.
- Showing empathy towards other community members

Examples of unacceptable behaviour by participants include:

- The use of sexualized language or imagery and unwelcome sexual attention or advances
- Trolling, insulting/derogatory comments, and personal or political attacks.
- Public or private harassment
- Publishing others' private information, such as a physical or electronic address, without explicit permission
- Other conduct which could reasonably be considered inappropriate in a professional setting.

Our Responsibilities

IDP maintainers and contributors are responsible for clarifying the standards of acceptable behaviour and are expected to take appropriate and fair corrective action in response to any instances of unacceptable behaviour.

The IDP maintainers have the right and responsibility to remove, edit, or reject comments, commits, code, wiki edits, issues, and other contributions that are not aligned with this Code of Conduct, or to ban temporarily or permanently any contributor for other behaviours that they deem inappropriate, threatening, offensive, or harmful.

Scope

This Code of Conduct applies both within IDP and CoST repository spaces and in public spaces when an individual is representing CoST or its community. Examples of representing CoST or the community include using an official email address, posting on an official social media account, or serving as an appointed representative at an online or offline event. Representation of a CoST may be further defined and clarified by the IDP maintainers.

Enforcement

Instances of abusive, harassing, or otherwise unacceptable behaviour may be reported by contacting this repository's maintainer or at opencode@infrastructuretransparency.org

All complaints will be reviewed and investigated, and will result in a response that is deemed necessary and appropriate to the circumstances. The CoST team is obligated to maintain confidentiality regarding the identity of the reporter of an incident.

The IDP maintainers who do not follow or enforce the Code of Conduct may face temporary or permanent repercussions as determined by CoST.
